

## Greenwood Award Recipient

his award is conferred annually in memory of George D. Greenwood (1892-1956) To a member who has been dedicated to his profession, faithful to his Dental Society and community undertaking and loyal to his colleagues throughout his career.

**TV** ho is Dr. George D. Greenwood, the mystic person so gratuitously honored each year with the award, emblazoned with his name? That award is presented each year to the "best of the best" member of the year of the Seventh district Dental Society. No one knows for sure, but rumors that he is related to the famous John Greenwood, George Washington's dentist, are just not true.

Dr. Greenwood is a product of the Nineteenth Century having been born in 1892. He attended the University of Buffalo, School of Dentistry, graduating in the Class of 1916. His practice was on the eleventh floor of the Mercantile Building in Rochester, with offices overlooking Main Street, as if he were the ruler of all below. As many dentists of the era, he thoroughly enjoyed complete denture therapy and was noted for his expertise.

Greenwood's involvement in organized dentistry was extensive as a leader, as well as a number crunching virtuoso. He progressed through the offices and ultimately served as president of the Rochester Dental Society (now known as the Monroe County Dental Society). He was Seventh District Dental Society Treasurer for many years, and served the Dental Society of the State of New York (now known as New York State Dental Association) in financial roles. In the forties and early fifties, Dr. Greenwood together with Dr. Charles Wilkie, State Society Secretary, were in essence a twoman steering committee of the state organization, with the Central Office functioning out of Charlie Wilkie's dental office in Brooklyn's renowned One Hanson Place building.


When George passed away in 1955, it was immediately apparent to the leadership of the District, that the memory and aura of this larger-than-life personality should be perpetuated. How better to do it than by way of the top District award being made in his name, to an outstanding member contributor to the Society and to the community? Thus the Award began in 1958, and continues to this day, year by year, developing the list that commemorates the district's most notable members.


### John R. Droter, D.D.S.

Dr. Droter graduated magna cum laude from the University of Maryland Dental School with a huge void in understanding TMJ problems. His quest for an understanding has led him to study most notably at the L.D. Pankey Institute, The Center for Advanced Dental Study with Dr. Peter Dawson and Dr. Mark Piper, The University of Florida's Facial Pain Center with Dr. Parker Mahan, Dr. Henry Gremillion, and Dr. Frank Dolwick, The University of California, San Diego with Dr. Terry Tanaka and with Dr. Guy Haddix in Statesville, NC.

Dr. Droter maintains a private practice diagnosing facial pain. He is able to utilize state of the art imaging and biometric techniques, when TMJ damage is suspected in causing facial pain. He provides nonsurgical TMJ rehabilitation for those patients with damaged joints. He is a visiting faculty member at Children's Hospital in Washington, DC and The Washington Hospital Center, teaching temporomandibular disorders to the orthodontic and pedodontic residents. He is a visiting faculty at the LD Pankey Institue in Florida. He is

also on staff at Anne Arundel Medical Center in Annapolis, where he works with surgeons in planning and carrying out complex facial and TMJ reconstructions. He lectures nationally and is honored to be included in the Dentistry's Todays Top Clinicians in Dental Continuing Education. His writings include published articles on the TMJ, a TMJ Manual written for patients and he is a contributing author to the teaching manuals at the L.D. Pankey Institute.

As health professionals of the highest rank we know the significance that they have had for the betterment of all those that sought their care. Each has left their families, associates and communities far better because of their lives. We mourn the loss of the following members:

Dr. Sherwin M. Morris, *died on August 20, 2008.* Sherwin was a popular orthodontist and son of a well known Rochester dentist. He received the Doctor of Dental Surgery degree in 1948 from The State University of New York at Buffalo School of Dental Medicine.

Dr. Collins W. Carpenter, died on August 25, 2008. "Connie" was a well respected oral and maxillofacial surgeon practicing and living in Canandaigua. He received the Doctor of Dental Surgery degree in 1945 from The University of Michigan School of Dentistry

**Dr. David Curtis**, *died September 22*, 2008. He received the Doctor of Dental Surgery degree in 1981 from Case-Western Reserve University School of Dentistry

Dr. Charles J. Mascari, *died on November 10, 2008.* He received the Doctor of Dental Surgery degree in 1938 from The State University of New York at Buffalo School of Dental Medicine. Charles was the 1973 President of the Seventh District Dental Society. He lived and practiced in Geneva.

**Dr. Richard M. Piccarreto**, *died on December 10, 2008*. He received the Doctor of Dental Surgery degree in 1965 from The State University of New York at Buffalo School of Dental Medicine.

**Dr. Harry Levin**, *died December 22*, 2008. He received the Doctor of Dental Surgery degree in 1949 from The State University of New York at Buffalo School of Dental Medicine.

**Dr. Robert Mueller**, *died on January 29*, *2009*. He received the Doctor of Dental Surgery degree in 1956 from The State University of New York School at Buffalo School of Dental Medicine.

**Dr. Irving Katzman**, *died on April 1, 2009.* "Irv" was a well known orthodontist. He received the Doctor of Dental Surgery degree in 1941 from the University of Michigan School of Dentistry.

**Dr. Morton Guttenberg,** *died April 2, 2009.* "Mort" is notable as the first limited practice endodontist in this area. Mort received the 2008 Award of Merit of the Seventh District Dental Society. He is a 1945 graduate of the University of Michigan School of Dentistry.

**Dr. Nicholas A. Nicosia**, *Died on April 12, 2009.* "Nick" is the 1983 president of the Seventh District Dental Society and received the district's George D. Greenwood Award in 1996. He received the Doctor of Dental Surgery degree in 1954 from The State University of New York at Buffalo School of Dental Medicine.
